## Coalition of Agencies Serving the Elderly (CASE) San Francisco Advocacy Statement

The Coalition of Agencies Serving the Elderly (CASE) represents more than 45 agencies that provide a continuum of services that empower seniors in San Francisco to age in place with dignity and with the support structures necessary to thrive. **CASE serves over 40,000\* seniors and people with disabilities and we are committed to increasing their participation in the city budget process.** Our goal is to be a visible and active part of the ongoing policy dialogue.

We recognize that we are living through one of the most challenging economic environments in 70 years. However, it is precisely in these times that our most vulnerable citizens, including the elderly, need our help the most. As we make tough decisions in the short-term, it is important that we remember:

- 1. We cannot afford to dismantle a continuum of care that will be needed to serve the greatest expansion of the senior population in our history. By 2030, 1 in 5 of San Francisco residents will be over the age of 65 and the number of residents over the age of 85 will double.
- We cannot afford to be 'penny wise and pound foolish' Home and Community based services reduce utilization of more costly alternatives hospitals, Skilled Nursing facilities, etc. Diminishing or dismantling community-based services will increase usage of these more costly alternatives. In addition, our core medical/ institutional services are inadequate and overburdened and cannot absorb increased demand that will follow reductions in home-based care.
- We cannot afford to break our social contract with seniors. We believe a society is judged by how it treats its most vulnerable members. Home and community-based services are part of a continuum of care for seniors and adults with disabilities so that they are able to live safely with dignity and independence in their homes and communities.
- 4. We cannot afford to lose valued resources Community providers operate efficiently, leverage resources, and are highly capable of responding quickly to the needs of the community. Programs and resources (buildings, etc.) that have developed over years, once cut may be difficult and costly to re-establish once funding increases again. Cutting senior services will mean that seniors will have less access to services that meet their basic needs (a meal, access to information and healthcare, to participate in social activities, etc.) while increasing their chances of isolation and hospitalization.
