Re: Request for meeting; Nonprofit cost-of-doing-business

Dear Mayor Lee:

In 2005, Mayor Gavin Newsom provided the first-ever cost-of-doing-business (CODB) increase in nonprofit contracts. Since that year, City leaders continue to express their recognition of the need to address stagnant salaries for front-line workers and inflationary increases in the costs of providing services. Despite this verbal support, however, actual increases have not kept pace with inflation, and nonprofits received flat funding for several years during the recent recession.

With the local economy in healthy recovery, the San Francisco Human Services Network requests that you include a cost-of-doing-business increase in the upcoming FY2014-15 budget. We also ask that you provide for this increase at the front end of the process by including it in your budget instructions, rather than at the end as part of budget negotiations during the Board of Supervisors' review.

HSN recently had meetings with Controller Ben Rosenfield, Budget Director Kate Howard and Board Budget Committee Chair Mark Farrell to discuss the need for a permanent solution to the CODB problem. For example, these conversations raised the idea of allowing nonprofits to include escalators in multi-year contracts, as is currently the case with the City's for-profit contractors. Ultimately, we hope to work with the City to develop a mechanism that will ensure the adequate funding and longterm sustainability of crucial services, while removing this issue from the annual politicized addback process.

We are also reaching out to members of the Board of Supervisors, and to SEIU and OPEIU, which represent workers in many of our organizations. To date, their responses have been positive regarding this approach.

We would like to engage in further discussion as soon as possible, and request that you and Kate Howard meet directly with HSN representatives before issuing your budget instructions.
