# FY16-17 and FY17-18 Budget

## FY16-18 Financial Outlook


- City General Fund situation continues to improve, but still facing deficits of \$99.8 and \$240.2 M deficits for FY 16-17 and FY 17-18, respectively.
- Revenue growth strong over the period (9.5%); but is outpaced by expenditure growth (21%)
- Includes 2.5% CODB increase in FY 16-17 for nonprofit contractors as proposed in prior year budget process. Future adjustments are still to be determined
- Major drivers of the projected deficit:
  - Increase in employer retirement contributions to employee pensions
  - Voter approved propositions and set-asides

## Mayor's Budget Instructions

- City departments propose 1.5% ongoing GF reductions year 1 and an additional 1.5% ongoing reduction in year 2. (\$9.5 and \$19.2 M for DPH)
- Reflect the priorities and programmatic goals identified in each department's proposed five year strategic plan
- > Support the development of a modern, responsive and engaged government:
  - Public trust and civic engagement
  - Public experience of city services
  - Performance, accountability, investing in what works
  - Giving employees the tools to do their best work
- Minimize service impacts

Identify and pursue opportunities for cross-departmental collaboration

#### **Recessions Scenario**

- Since 1900, average length of time between recessions has been 46 months. The current economic expansion has lasted over 76 months.
- If no recession through FY20, it will mark the longest economic expansion since 1900.

- Selecting and implementing a new integrated electronic medical record
- > Opening the new San Francisco General Hospital
- Continuing focus on access and patient retention
- Creation of the Department of Homelessness

- June 1 Mayor's Balanced Budget Submission

#### Updates to DPH Contracting

#### RFP's and System Planning in FY15-16 and FY16-17

- There are a number of contracts that are set to expire as of 12/31/15 (many from the CBHS "mega RFP").
- There has been a system planning process, started but not completed, to evaluate the Department's service needs under the Affordable Care Act and other Statewide changes. Planning has concluded in some areas, but not in others.
- Contractors will be updated on conclusions from the planning process and next steps. In the meantime...
- The Department is in the process of requesting sole source extensions through 12/31/17 for all expiring contracts. Contracts exceeding \$10 million over the term of the funding require approval by the Board of Supervisors. Most have already gone.
- The goal is to issue RFP's on a rolling basis, with some RFPs to be issued in FY15-16, and effective as of July 1, 2016 (FY16-17), with others staggered to begin by July 1, 2017.

- Improving Medi-Cal Documentation
- Early Identification of financial issues with contracts
