VOTE ON TUESDAY, JUNE 5, 2018!

On June 5, San Franciscans will go to the polls to vote on ballot measures with significant impacts on **funding for childcare, housing, tenant eviction defense and more.**

As a voice for nonprofits, HSN provides a unique contribution to the City by educating service providers, policymakers and the community on how policy decisions affect the health and human services safety net.

* YES on B – Good government measure reduces conflicts of interest

Prop B requires appointed public officials to step down if they run for public office. It prevents them from voting on matters involving people who might support or oppose their campaign. http://sfgov.org/elections/sites/default/files/Documents/Appointed_Board_Comms_Seeking_Elected.pdf

* YES on C – Taxes commercial landlords to fund childcare and early education

This measure will raise \$146 million a year to address San Francisco's long waiting list for childcare services, and higher wages for childcare workers. A portion of the funds may be allocated to IHSS worker wages. <u>https://www.earlyeducationsf.com/</u>

* YES on D – Taxes commercial landlords to fund housing and homelessness services

This measure will raise \$70 million a year, with 45% for homeless services, 10% to fund single room occupancy units, 35% to protect and create rent-controlled and affordable housing, and 10% to subsidize low-income senior housing. <u>https://www.sfhousingforall.com/</u>

* YES on F – Makes sure that all residential tenants have lawyers to fight evictions

Prop F requires the City to fund legal counsel for all residents whose landlords attempt to evict them. These programs equal the playing field, and prevent homelessness. <u>https://www.sfrighttocounsel.com/</u>

* NO on H – Don't let the Police Officers Association write its own Taser regulations

San Francisco has decided to arm police with Tasers, and the Police Commission approved regulations based on best practices and community input. This measure would adopt a less restrictive policy favored by the police officers' union. <u>https://votenoproph.nationbuilder.com/</u>
